Mr. Nagai made a motion to add addendum items to agenda and approve consent agenda. Mrs. Budka seconded the motion. Extra-Curricular reports are added to the monthly minutes per suggestion of our latest audit. A question was asked on what is Reach Out Club—that is PTO funds. After all questions were answered the board voted to approve the consent agenda 5-0.

3.0 Discussion/Action Items

- 3.01 Consideration to approve request by Starke County 4-H Council to use two school buses on June 7th to transport 4-H members to Camp Mack. Motion was made by Mr. Nagai with a second by Mr. Lawrence. This is something the corporation allows every year. Motion passed 5-0.
- 3.02 Recommendation to approve awarding scholarships and Academic Honor Diplomas as listed. Motion made by Mr. Nagai, second by Mrs. McIntosh. Eleven Academic Honors, two Koontz Lake Scholarships and eight for the Louis and Linda Berg Scholarship. Motion passed 5-0.

- 3.03 Recommendation to approve TMS-Engineering thru Five-Star Technology Solutions. Motion made by Mr. Nagai, second was made by Mrs. McIntosh. Mr. Briles has agreed to be an ambassador for them as long as it meets our expectations and the total cost for our corporation is \$30,000. We will keep our own technicians they are not hiring anyone. This will be for them to work on the backbone of our technology. This cost is not adding to budget but is coming out of grants. Motion passed 5-0.
- 3.04 Recommendation to approve changes in handbooks. Motion made by Mr. Nagai and seconded by Mr. Lawrence. The elementary changes were basically date changes and a couple of vaccination changes. The Jr/Sr High School draft had the changes in red. There was a committee that worked on this. There may be some changes coming as far as how attendance will affect intercessions and students attending. Most of the changes were tightening up and clarifying. Motion passed 5-0.
- 3.05 Summer Maintenance Projects as listed. Before a motion was made there was discussion on the list. After considerable discussion on each item on the list it was decided to prioritize the list as far as items that were needed to be done now and those that needed more time to collect all bids and information. A walk-through will be scheduled for sometime in June for the board to actually see the items put on hold. Mr. Nagai made a motion to approve the items listed under Phase 1 with Mrs. Budka seconding the motion. Motion passed 5-0.
